## Self - Compliance Report

RoHS: Directive 2002/95/EC of the European parliament and of the council of 27 January 2003 on the restriction of the use of certain hazardous substances in electrical and electronic equipment.

RoHS 2: Directive 2011/65/EU, was published in July 2011 by the European Commission. The scope of the original RoHS was expanded to cover all electrical/electronic equipment, cables, and spare parts with compliance required by July 22, 2019 or sooner depending on product category.

RoHS 3: Directive 2015/863 was published in 2015 by the EU, and adds four additional restricted substances (phthalates) to the original list of six, as cited under REACH legislation.

We hereby declare that none of the 10 substances listed in the table below were used intentionally, or are included in amounts above the permissible limits for the qualities and products mentioned above, during any time or production and work processes of AHenriques.

It is important to note that this statement applies only to the parts that are produced or assembled within our production facilities. As soon as these parts are assembled into a subsequent end product, this shall not apply. We will not accept liability for other materials or processes used in combination with the parts in order to produce a final product.
